## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0

- mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
  5. Incubate the tubes and plate at 37°C for 24 hours.

## **Notes**

Colonies on #3 plates are raised, entire, glistening, circular, smooth, and translucent. This strain was confirmed by PCR to not carry the *eae*, *stx1*, and *stx2* genes (*stx1*-, *stx2*-, *eae*-).
