### **Handling Procedures**

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml

with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

**3. Aseptically transfer this aliquot back into the broth tube. Mix well.**

**4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.**

5. Incubate the tubes and plate at 37°C for 24 hours.

### **Notes**

Colonies on #18 agar are opaque, circular, entire, low convex, and glistening.
