Clostridium perfringens strain NCTC 8238 [281/50] is a bacterial anaerobe isolated from boiled salt beef. The *cpa* (Alpha toxin) and *cpe* (Enterotoxin) genes were confirmed to be present in this strain.

ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open vial according to enclosed instructions.
2. Under anaerobic conditions, withdraw 0.5 mL of #2107 broth from a single test tube (5 to 6 mL) and rehydrate the entire vial contents.
3. Aseptically transfer this aliquot back into the broth tube. Additional tubes may be inoculated with 0.5 mL each from the suspension. A slant of #2107 may also be inoculated with 0.2 mL. Streak several blood plates to check for colonial morphology and purity.
4. Incubate tubes under an anaerobic atmosphere at 37°C for 24 hours. Incubate one agar plate anaerobically for colony formation and one aerobically for aerobic contamination check.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

Notes

Anaerobe Systems Brucella Blood plate (AS-111 or AS-141) can be used to analyze colony morphology and purity.

No growth should occur on agar plate incubated aerobically.

This strain is used in media testing (International Organization for Standardization/ANSI; ISO 11133-2: 2003, British Standards Institution; British Standard DD CEN ISO/TS 11133: 2003).
