Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### **Medium:**

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

**Temperature:** 37°C

## **Handling Procedures**

- 1. Open vial according to enclosed instructions.**
- 2. From a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**

4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
  5. Incubate all tubes and plate at 37°C for 24 hours.

## **Notes**

Colonies on #260 plates are entire, glistening, circular, and smooth. It produces alpha hemolysis on sheep blood agar.
