### Medium:

ATCC Medium 814: GC Agar/Broth Medium

**Temperature:** 37°C

## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #814 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.

**4. Use 0.2 ml of the suspension to inoculate a #814 slant, and/or a plate.**

5. Incubate all tubes and plate at 37°C with 5% CO<sub>2</sub>. Growth should occur in 24-48 hours. Assure that screw caps are loose during incubation period.

Colonies on #814 circular, entire, glistening, and off-white.
