Handling Procedures

1. Open vial according to enclosed instructions.
 2. Using a single tube of #1877 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #196 agar slant and/or plate.
 5. Incubate the tubes and plate at 26°C for 5-7 days.

Notes

Colonies are white with pale gray-green aerial mycelium. The substrate is a golden color that becomes darker with age.

This strain is cited to produce chromomycin A3 and cytochrome P450 (1-3).
