## Handling Procedures

1. Open vial according to the enclosed instructions.
  2. Using a single tube of ISP #1 broth (5 to 6 ml), withdraw approximately 0.5 ml to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
  3. Aseptically transfer this aliquot back into the broth tube and mix well.
  4. Use several drops of the cell suspension to inoculate a second tube of broth, a slant and/or a plate.
  5. Incubate all tubes and plate at 26°C for at least 7 to 14 days.

## Notes

Colonies on #196 agar are white, opaque, convex-drop like, dry, rough, and wavy. The aerial mycelium is white with medium gray and the substrate mycelium is mustard-yellow.
