### **Handling Procedures**

- 1. Open vial according to the enclosed instructions.**
  - 2. Using a single tube of ISP #1 broth (5 to 6 ml), withdraw approximately 0.5 ml to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
  - 3. Aseptically transfer this aliquot back into the broth tube and mix well.**
  - 4. Use several drops of the cell suspension to inoculate a second tube of broth, a slant and/or a plate.**
  - 5. Incubate all tubes and plate at 26°C for 3-5 days.**
