Handling Procedures

- 1. Open vial.
- 2. Under anaerobic conditions aseptically rehydrate the entire pellet with approximately 0.5 mL of #132 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #132 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes. Best practice dictates the use of pre-reduced media.
- 3. Use several drops of the primary broth tube to inoculate a #132 plate and/or



#132 agar slant.

4. Incubate in an anaerobic atmosphere at 37°C for 24-48 hours. Incubate one agar plate aerobically at 37°C to check for contamination.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

Notes

Growth should occur within 24 to 48 hours. Colonies on #132 agar appear small, circular, entire, smooth, glistening, and convex with white centers. No growth should occur on agar plates incubated aerobically.
