Handling Procedures

1. Open vial.
2. Rehydrate the entire pellet with approximately 0.5 mL of # 18 broth.
Aseptically transfer the entire contents to a 5-6 mL tube of # 18 broth.
Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.

3. Use several drops of the primary broth tube to inoculate a # 18 plate and/or #18 agar slant.
 4. Incubate at 37°C for 24 hours.

Notes

Shaking of broth cultures has been shown to improve growth.

Medium #129 (Nutrient Agar with 0.5% NaCl) is recommended for phage propagation.
