Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
5. Incubate all tubes and plate at 37°C for 24 hours.

Notes

Colonies are entire, glistening, smooth, and translucent. Cells are Gram negative, thin, slightly curved rods.

Vibrio cholerae strains do not require NaCl for growth.

Most *Vibrio* strains do not remain viable for more than a few days, even at refrigerator temperatures. To avoid frequent transfers, it is recommended that cells be frozen with a suitable cryoprotectant.
