## Handling Procedures

1. Open the freeze-dried vial according to enclosed instructions.
  2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the pellet.
  3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a #3 slant, and/or plate
  5. Incubate all tubes and plates at 30°C for 24 to 48 hours.

## Notes

Two colony types are observed: a) irregular, umbonate, smooth, and cream; b) circular, entire, smooth, and cream.

Cells are non-motile with cocco-bacillary and rod forms, occurring singly, in pairs, threes and chains.
