### **Handling Procedures**

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
- 5. Incubate the tubes and plate at 26°C for 24 to 48 hours. Additional incubation time may be required for growth on agar (48 to 72 hours).

#### Notes

Colonies on #18 plates are entire, small, glistening, circular, smooth, translucent, and convex. This strain produces brown diffusible pigment on agar.
