Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 26°C

Handling Procedures

1. Open freeze-dried vial according to instructions.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Incubate broth at 26°C for 72 hours.
5. Transfers may now be made to solid medium. Additional incubation time may be required for growth on agar (72+ hours).

Strain will also grow on Trypticase Soy Agar (BBL 11043) without the added sheep blood.

Colonies are small, entire, glistening, smooth, and opaque.
