Handling Procedures

1. Open the vial according to enclosed instructions.
 2. From a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1 ml with a Pasteur or 1.0 ml pipette. Rehydrate the pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
 5. Incubate all tubes and plate at 37°C for 24 to 48 hours.
