## Growth Conditions

**Medium:**

ATCC Medium 416: Lactobacilli MRS Agar/Broth

**Temperature:** 37°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

## Handling Procedures

1. Open vial.
2. From a single tube of #416 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well
4. Use several drops of this suspension to inoculate a second tube of broth, a

slant and/or a plate.

5. Incubate tubes and plate at 37°C in an atmosphere of 5% CO<sub>2</sub> for 24 to 48 hours. Loosen screw caps of all test tubes during the incubation period.

## Notes

The CO<sub>2</sub> is not necessary for growth but may enhance it.
