Temperature: 26°C

Handling Procedures

1. Open vial according to enclosed instructions.
 2. Using a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.5 ml to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube and mix well.
 4. Use several drops of the cell suspension to inoculate a second tube of broth, a slant and/or a plate.
 5. Incubate all tubes and plate at 26°C for 7 days.

Notes

Vegetative cells are discrete, smooth and cream to yellow in color. Aerial mycelium is white/ash gray, dry, and moderate. Sporophores are branched with hooks and spirals, spores are spherical and oval.
