Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Medium: ATCC Medium 142: Lactobacillus sake medium Temperature: 30°C Atmosphere: Aerobic

#### Handling Procedures

- 1. Open vial.
- Using a single tube of #142 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.

- 4. Use several drops of the suspension to inoculate a second tube of broth, a slant and/or plate.
- 5. Incubate tubes and plate at 30°C in an aerobic atmosphere for 48 hours.

#### Notes

After 48 hours, growth is evident by turbidity with a granular pellicle in the broth. This strain grows poorly on agar. Best growth is obtained in broth culture or on biphasic slants. The cells are Gram positive rods, regular in shape, with chain formation.
