## **Handling Procedures**

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate an additional broth tube, a #3 agar slant and/or a plate.
- 5. Incubate all tubes and plate at 30°C for 24 to 48 hours.

#### Notes

Two colony types are observed: a) circular, convex, and less dense than colony b, with an undulate margin, and wrinkled surface; b) circular, entire, convex, and mucoid. Wet colonies tend to coalesce.
