Description

Pseudomonas aeruginosa strain 1C is a whole genome-sequenced strain that was isolated from an infected wound. It produces pyochelin and pyocyanin, and it can be used as a bacteriophage host or for opportunistic pathogen for research.

Handling Procedures

1. Open vial according to enclosed instructions.

2. Using a single tube of #129 or #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #129 or #3 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 24 hours.
