Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Under anaerobic conditions, withdraw 0.5 mL of recommended broth from a single test tube (5 to 6 mL) and rehydrate the entire vial contents.
- 3. Aseptically transfer this aliquot back into the broth tube. A slant and a prereduced blood plate may also be inoculated with 0.1 mL each of the cell suspension. An aerobic blood plate may also be streaked to check for purity.
- 4. Incubate tubes and plate under anaerobic conditions at 37°C. Incubate the

second blood plate aerobically at 37°C.

5. Within 48 hours, growth should be evident by turbidity in the broth. No growth should occur on the blood agar plate incubated aerobically.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

Notes

Colonies on #260 media are entire, smooth, glistening and low convex. This strain is sited to produce restriction endonuclease BbeAI and BbeAII. (3)
