Handling Procedures

1. Open vial according to enclosed instructions.

2. Using a single tube of #2107 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.

5. Incubate the tubes and plate at 37°C for 48 hours.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

 \cdot Use of an anaerobic gas chamber, or

· Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

· Loose screw caps on test tubes in anaerobic chamber,

· Loose screw caps on test tubes in an activated anaerobic gas pack jar, or

 \cdot Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

Notes

Colonies on #260 are small, circular, convex, and smooth with an entire margin.
