- ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 24 hours.

Colonies on #3 plates are entire, glistening, circular, smooth, raised, and translucent.
