Handling Procedures

1. Open vial according to enclosed instructions.
 - 2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
 - 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**
 - 4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.**
 5. Incubate the tubes and plate at 26°C for 24 hours.

Notes

Colonies on #3 agar are entire, glistening, circular, smooth, translucent, and low convex.

If grown on King's Medium A, colonies will be entire, glistening, smooth with a bright red edge and white center.

King's Medium A:

Peptone, 20.0 g

Glycerol, 10.0 g

K₂SO₄ (anhydr.), 10.0 g

MgCl₂ (anhydr.), 1.4 g

Agar, 20.0 g

Distilled water, 1 L

Adjust pH to 7.2 if necessary.
