Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. From a single test tube of **sterile distilled water** (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a sterile pipette and apply directly to the pellet. Stir to form a suspension.
- 3. Aseptically transfer the suspension <u>back</u> into the test tube of sterile distilled water.



- 4. Let the test tube sit at room temperature (25°C) undisturbed for **at least 2 hours**; overnight rehydration is recommended.
- 5. Mix the suspension well. Use several drops to inoculate recommended solid or liquid medium.
- 6. Incubate cultures at recommended temperature.
