Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Open vial according to enclosed instructions.**
- 2. Using a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or glass pipette. Rehydrate the pellet.**
- 3. Transfer this aliquot back into the broth tube. Mix well.**
- 4. Use several drops of the suspension to inoculate a second tube of broth, one or two slants and/or a plate.**
- 5. Incubate all tubes and plate at 26**
