## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #217 broth, withdraw 0.5 mL and rehydrate the entire pellet.
3. Transfer the rehydrated pellet back into the tube of broth. Inoculate a #217 slant and/or plate. Inoculate a plate of a non-selective medium to test for

contaminates.

4. Incubate the tubes and plates at 37°C. Growth can take 7 to 14 days to appear. Solid media may have to be reinoculated from incubated broth if no colonies appear.
