Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## **Handling Procedures**

#### PROPAGATION PROCEDURE:

- 1. Open vial according to enclosed instructions.
- 2. Under anaerobic conditions, withdraw 0.5 ml of the recommended broth from a single test tube (5 to 6 ml) and rehydrate the entire vial contents.



- 3. Aseptically transfer this aliquot back into the broth. Additional tubes may be inoculated with 0.5 ml each from the suspension. 0.1 ml may also be inoculated onto a slant. Streak several blood plates to check for colonial morphology and purity.
- 4. Incubate tubes under an anaerobic atmosphere at 37°C. Incubate one agar plate anaerobically for colony formation, and one aerobically for aerobic contamination check.
- 5. Within 48 hours, growth should be evident by turbidity and gas in the broth; and heaped, smooth, white colonies with an irregular margin on #260 agar. No growth should occur on agar plates incubated aerobically.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- · Use of an anaerobic gas chamber, or
- · Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- · Loose screw caps on test tubes in anaerobic chamber,
- · Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- · Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.
