Handling Procedures



- 1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
- 2. Under anaerobic conditions aseptically rehydrate the entire pellet with approximately 0.5 mL of #2107 or #1080 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #2107 or #1080 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes. Best practice dictates the use of pre-reduced media.
- 3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #2107 agar slant.
- 4. Incubate in an anaerobic atmosphere at 37°C for 24-48 hours. Incubate one agar plate aerobically at 37°C to check for contamination.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

Notes

Anaerobe Systems PRAS Brucella Blood Plates (AS-111 or AS-141) can be used to analyze colony morphology and purity. No growth should occur on the aerobic blood plate.

The presence of the genes for toxins A and B confirmed by PCR.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions.
