Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Thaw the frozen vial under anaerobic conditions.
2. Under anaerobic conditions, transfer the entire contents of the thawed vial into a single tube (5-6 ml) of #2107 broth. Mix well.
3. Additional tubes of broth may be inoculated with 0.5 ml each from the

suspension and 0.1 ml may be inoculated onto a slant. Streak a Brucella blood plate and/or #260 blood plate to check for colony morphology and an additional blood plate for purity.

4. Incubate tubes under an anaerobic atmosphere at 37°C. Incubate one Brucella and/or #260 agar plate anaerobically for colony formation, and one blood plate aerobically for aerobic contamination check. Turbid growth is evident in the broth at 24 to 48 hours.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

Notes

Anaerobe Systems Brucella Blood Agar Plates (AS-111) can be used to analyze colony morphology and purity.

Presence of *tcdA* and *tcdB* genes confirmed by PCR.

Toxin B production confirmed by cytotoxicity assay using Vero cells (Cell line #CCL-81). Binary toxin gene *cdtB* not amplified by PCR
