## **Handling Procedures**

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #185 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37°C for 7 to 10 days.

#### Notes

Not a Streptomyces, contains meso-DAP.

Growth appears white with a light brown substrate.
