ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 37°C

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.

Notes

On #260 plates there are two colony types. One colony is circular, glistening, smooth, entire, low convex, and translucent. The second colony is larger, opaque with an irregular margin.
