Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

Medium:

ATCC Medium 200: YM agar or YM broth

Temperature: 25°C

Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single test tube of **sterile distilled water** (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a sterile pipette and apply directly to the pellet. Stir to form a suspension.
3. Aseptically transfer the suspension back into the test tube of sterile distilled water.

- Let the test tube sit at room temperature (25° C) undisturbed for **at least 2 hours**; overnight rehydration is recommended.
 - Mix the suspension well. Use several drops to inoculate appropriate solid or liquid media (see **atcc.org** for a recommended medium and temperature).
 - Incubate cultures at appropriate temperature. Remaining suspension may be stored in refrigerator for possible reuse, although no survival time can be specified.
