For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

**Medium:** ATCC Medium 200: YM agar or YM broth **Temperature:** 23°C

# Handling Procedures

1. Open vial according to enclosed instructions.

2. From a single test tube of **sterile distilled water** (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a sterile pipette and apply directly to the pellet. Stir to form a suspension.

3. Aseptically transfer the suspension back into the test tube of sterile distilled water.

4. Let the test tube sit at room temperature (25° C) undisturbed for **at least 2 hours**; overnight rehydration is recommended.

5. Mix the suspension well. Use several drops to inoculate appropriate solid or liquid media (see **atcc.org** for a recommended medium and temperature).

6. Incubate cultures at appropriate temperature. Remaining suspension may be stored in refrigerator for possible reuse, although no survival time can be specified.
