Handling Procedures

- 1. Thaw vial according to enclosed instructions.
- 2. Transfer thawed suspension to a single tube of #1849 broth. Mix well.
- 3. Incubate at 30°C for six days.
- 4. Transfers may be made to solid medium if desired (see note).

Notes

ATCC 19072 will also grow on ATCC Medium #2, Marine Broth (Difco 0791) or Agar (Difco 0979). A more turbid growth is obtained on Harpo's HYTEM (Marine) Medium. Broth culture is recommended because the strain digests agar. Autolysis begins in approximately seven days. Strain is preserved in a frozen state.
