Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

ATCC Medium 2: Marine agar 2216 or marine broth 2216

Temperature: 26°C

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #2 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate an additional broth tube, a #2 agar slant and/or a plate.

5. Incubate all tubes and plate at 26°C for 24 to 48 hours.
6. If poor growth is observed on agar surfaces, transfer from the grown broth to fresh plates and/or slants.
7. After growth has been achieved, additional transfers may be made or cells prepared for storage. This strain dies off rapidly once the stationary phase is reached, even at refrigerator temperatures. To avoid frequent transfers, it is recommended that cells be frozen with a suitable cryoprotectant.

Notes

On #2 agar colonies are entire, circular, glistening, and translucent.
