Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

ATCC Medium 2: Marine agar 2216 or marine broth 2216

Temperature: 26°C

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #2 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #2 agar slant and/or plate.
5. Incubate the tubes and plate at 26°C for 48 hours.
6. After growth has been achieved, additional transfers may be made or cells

prepared for storage. Most *Vibrio* species will die off rapidly once the stationary phase is reached, even at refrigerator temperatures. To avoid frequent transfers, it is recommended that cells be frozen with a suitable cryoprotectant.

Notes

Colonies on #2 agar are flat, spreading, irregular, and translucent.
