For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Medium:

ATCC Medium 230: Antibiotic medium #1 with 20 mcg per ml of tetracycline, streptomycin, and chloramphenicol

Temperature: 37°C

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #230 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #230 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

This strain is resistant to chloramphenicol, tetracycline, and streptomycin. It is maintained on a medium containing these antibiotics to retain these characteristics. However, it will grow on standard media such as Nutrient Broth and Agar, Tryptic Soy Broth and Agar, etc.

On standard media as described above, colonies are glistening, smooth, and slightly irregular, with some variation in opacity and size. On #230 medium, growth is slower to develop and the colonies appear more irregular, smaller, with more variation in size.
