## Handling Procedures

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #44 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #44 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to

these secondary broth tubes.

3. Use several drops of the primary broth tube to inoculate a #44 or 260 plate and/or #44 agar slant.
  4. Incubate at 37°C for 48 to 96 hours in an atmosphere of 5% CO<sub>2</sub>.
