### Handling Procedures

- 1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
- 2. Rehydrate the entire pellet with approximately 0.5 mL of #44 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #44 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to



these secondary broth tubes.

- 3. Use several drops of the primary broth tube to inoculate a #44 or 260 plate and/or #44 agar slant.
- 4. Incubate at 37°C for 48 to 96 hours in an atmosphere of 5% CO<sub>2</sub>.
