For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

**Growth Conditions****Medium:**

ATCC Medium 3: Nutrient agar or nutrient broth

**Temperature:** 26°C

---

**Handling Procedures**

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Incubate broth at 26°C for 72 hours.

5. Transfers may now be made to solid medium. Additional incubation time may be required for growth on agar (72+ hours).

**Notes**

Growth is indicated by turbidity in the broth; and small, entire, glistening, smooth, translucent colonies on agar surfaces. After 72 hours incubation, a weak brown water-soluble pigment is formed.

Culture will also grow on Trypticase Soy Broth and Agar (ATCC Medium #18). The addition of 5% Defibrinated Sheep Blood to medium #18 will enhance growth.
