Handling Procedures

Centrifuge tube prior to opening to prevent loss of pelleted material

1. Rehydrate contents of vial with molecular grade H₂O.
 2. Place vial at 37°C for 1 hour or at 2°C to 8°C overnight.
 3. For more complete rehydration and to fully recover DNA, incubate the sample overnight at 4°C while
 4. rocking; then incubate for 1 hour at 65°C. Resuspending the dried DNA in ≥ 250 µL may give better results.

Electrophoresis - RNA content: No RNA was detected by electrophoresis

Total amount: Total DNA by PicoGreen[®] measurement was found to be approximately 5 µg.
