Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of #197 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
- 4. Use several drops of this suspension to inoculate an additional broth tube, a #197 agar slant and/or a plate.
- 5. Incubate the tubes and plate at 30°C for 24 to 48 hours.

On #197 agar, colonies are entire, glistening, and smooth. There is variation is size and opacity. Cells are very pleomorphic.
