Handling Procedures

1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #260 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #260 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary

- broth tube to these secondary broth tubes.
3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
 4. Incubate at 37°C for 24 hours in an atmosphere of 5% CO₂.

ATCC Medium #2023, BHI with 10% inactivated horse serum, can be used as a substitute broth.
