Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

1. Open vial according to enclosed instructions.
- 2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**
- 4. Use several drops of the suspension to inoculate a #44 agar slant and/or plate.**

5. Incubate the tubes and plate at 37°C for 24 hours.

Colonies on #44 plates are entire, glistening, circular, smooth, and translucent.

Reported to exhibit high radiation resistance (1-4).
