Medium: ATCC Medium 200: YM agar or YM broth Temperature: 28°C

Handling Procedures

Do not under any circumstance store test tube at refrigerator freezer temperatures (generally -20°C). Storage of frozen material at this temperature may result in the death of the culture.

1. Using sterile technique, transfer one or more agar blocks bearing the fungus to tubes or plates of recommended medium. New culture may grow more quickly if mycelium is placed in contact with the fresh <u>moist</u> medium.

2. Incubate cultures at recommended temperature. <u>Do not allow medium to dry out</u>.

Transfer to fresh medium every two weeks.
