Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

Frozen ampoules packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampoules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampoules at refrigerator freezer temperatures** (generally -20°C). Storage of frozen material at this temperature will result in the



death of the culture.

1. To thaw a frozen ampoule, place in a 25°C to 30°C water bath, until just thawed (approximately 5 minutes). Immerse the ampoule just sufficient to cover the frozen material. Do not agitate the ampoule.

2. Immediately after thawing, wipe down ampoule with 70% ethanol and as eptically transfer at least 50 μ l (or 2-3 agar cubes) of the content onto a plate or broth with medium recommended.

3. Incubate the inoculum/strain at the temperature and conditions recommended.

4. Inspect for growth of the inoculum/strain regularly. The sign of viability is noticeable typically after 1-2 days of incubation. However, the time necessary for significant growth will vary from strain to strain.

Notes

High temperature sensitive lethality: cell lysis (CP3).

STX673-12C (ATCC 208627) and STX667-7C (ATCC 208628) were constructed at the YGSC at the request of Dr. De Angelis who needed temperature-sensitive strains which were also proteinase deficient and transformable. Parents used for the crosses were: the proteinase deficient strain BJ5458 (ATCC 208283), the cly2-1 strain STX464-5C (ATCC 208626), and the transformable strains YPH258 (ATCC 204674) and XS1385-6D (ATCC 204668).
