1. Open vial according to enclosed instructions.
 2. From a single tube of #416 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well
 4. Use several drops of this suspension to inoculate a second tube of broth, a slant and/or a plate.
 5. Incubate tubes and plate at 37°C in an atmosphere of 5% CO₂ for 24 hours. Loosen screw caps of all test tubes during the incubation period.

Notes

After 24 hours, growth is evident by turbidity in the broth and the formation of small colonies on the slant and/or plate. Growth is best in broth culture or on biphasic slants. On #416 plates, colonies are entire, glistening, circular, small, convex, and translucent.
