Medium: ATCC Medium 10: Nutrient agar/broth (in tap water) with 25% soil extract (ATCC Medium 191) Temperature: 50°C



1. Open vial according to enclosed instructions.

2. Using a single tube of #10 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a #10 agar slant and/or plate.

5. Incubate the tubes and plate at 50°C for 2 days.

Notes

Colonies on #10 agar have grayish yellow aerial mycelium and light brown substrate mycelium.
