## **Handling Procedures**

- 1. Open vial according to enclosed instructions.**
  - 2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or glass pipet. Rehydrate the entire pellet.**
  - 3. Transfer this aliquot back into the broth tube. Mix well.**
  - 4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.**
  - 5. Incubate all tubes and plate at 30°C for 24 to 48 hours.**

## **Notes**

Colonies on #3 agar are circular, cream in color, and opaque; with entire margin, convex elevation, and smooth surface. Cells are short, non-motile, Gram positive rods.
